SUBJECT: UPDATE ON EMPLOYEE HIRING/EMPLOYEE COUNT

The purpose of this memorandum is to provide the Superintendent and the Board of Trustees an update on the number of employees hired for the 2015-2016 school year as of August 5, 2015. The number of employees includes people that are new to the Sweetwater Union High School District, those hired from our substitute pool, and employees re-hired from a temporary contract in 2014-2015 school year.

As of August 5, 2015, the following number of employees have been hired:

- Certificated Contracts issued = 86
 - Rehires = 49
 - New First Time Contracts = 37
- Management new to position = 13
Assistant Superintendent, General Counsel, Principal Small School/Academy, Program Manager, School Psychologist, Planning Project Manager, Assistant Principal, and Assistant Principal-Student Activities.
- Classified Personnel = 16
 - Hired from Substitute pool = 13
 - New to the District = 3
