SUBJECT: CERTIFICATE SUBSTITUTE RATE OF PAY TEMPORARY **INCREASE**

The purpose of this memorandum is to provide background information to the Superintendent and to the Board of Trustees on the temporary increase to the certificated substitute rates and information on the rates from districts within the San Diego County.

During the 2013-2014 school year, the District began to see an increase in the number of substitute assignments that remained "unfilled". At that time, the decision was made to minimize the number of professional development activities scheduled for Fridays and Mondays since normally these days yield a high number of employee absences. Priority was given to fill absences for listed with a reason of "illness" over any other reason (i.e. professional development, personal necessity, etc.). School sites were instructed to have staff report to the school site prior to attending any scheduled professional development activity to ensure their classrooms were covered. During the second semester of 2013-2014 SY, there were days when the "unfilled" rate reached a peak with over 100 positions remaining unfilled. At that time, the Superintendent approved the temporary increase of the substitute rate to mitigate the "unfilled" rate. The temporary increase has been reviewed at every semester since May 2014. The rates changed as follows:

Each time the temporary increase was approved, it was advertised on SubFinder and as substitutes accessed the web connect system the information was listed in bold red letters. The temporary increase was listed on the site with a start date and an end date, based on the approvals. This is the timeline of the approvals/action:

• Initial approval by Dr. Edward Brand May 28, 2014 – June 6, 2014 for temporary increase:

\$115 PER DAY (5 periods and prep) to \$125 PER DAY \$138 PER DAY (6 periods no prep) to \$150 PER DAY

- Extension approved by Dr. Edward Brand June-2014 for first three months of the 2014-2015 school year (July-September 2014).
- Extension approved by Dr. Tim Glover September 29, 2014-December 19, 2014.
- Extension approved by Dr. Tim Glover January 13, 2015-March 31, 2015.
- Extension approved by Mr. Phil Stover April 1, 2015-June 5, 2015.
- Discussions in Cabinet 6/23/2015 and 7/14/2015 review of substitute rates/county information; seek approval to continue higher rate of pay for 2015-2016 school year. No decision was made.
- Notification to site secretaries of rates reverting back to established rates and message removed from web connect July 15, 2015.

With regards to communication of the change to revert back to the regular rates, there is no evidence that Human Resources (HR) sent individual notifications. The message outlining the temporary increase on the web connect log-in was removed. In the future, decisions on sub rates will be communicated, by HR, to the entire substitute staff via individual email communication.

Additionally, there was a request to provide information for the rate of pay for substitutes in Chula Vista School District and contract language for San Diego Unified School District (SDUSD). Chula Vista Elementary School District recently raised their substitute teacher rate to \$122 per day and \$132 for long term sub assignments. San Diego Unified School District (SDUSD) substitute teachers are covered under the collective bargaining agreement. The contract language along with the hourly salary schedule is attached. The hourly salary schedule is dated July 1, 2014; however, their tentative agreement states that there is a 4% increase effective July 1, 2015.

SDUSD substitutes pay union fees in the amount of \$34.57 per month. The Payroll staff deducts $\frac{1}{2}$ the payment \$17.28 on the 10th of each month and deducts \$17.29 on the 31st of each month. The amount is deducted each month a substitute has earnings based upon a 10 month academic calendar.

Human Resources is currently obtaining the most recent information on substitute rates from neighboring school districts. To date, thirteen (13) districts have responded and of the thirteen (13) districts who have responded six (6) have raised their certificated substitute rate.

As of August 27, 2015, Human Resources has received approval to continue with the temporary increase to be effective July 1, 2015. The Payroll Department will be making adjustments to pay for substitutes who worked during the month of July. If there is interest in making the rate change permanent, attached are the rates for all substitute services that can be presented to the Board of Trustees for approval.
