Our school campuses extend across several acres, which represents multiple means through which we can serve students with nutritious food. With the installation of mini cafeterias, the Nutrition Services Department will be able to expand their scope of service and will be given the opportunity to bring the cafeteria to the students.

Nutrition Services has to be nimble and proactive in providing a great dining experience wherever students are congregating. The mini cafeteria concept cuts down on travel time, affording the students an opportunity to socialize and receive a highly satisfying and nutritious meal. This allows us to increase the number of students who participate in our meal program. During a pilot program at San Ysidro High School (SYH) last year, there was an eight percent growth in meals served; thus validating the investment, and more importantly, reducing the time students have to wait to be served.
